Deed Book #1, page 33 and 34, 15 November 1800

This Indenture made this fifteenth day November eighteen hundred between John Pope of Shelby county & State of Kentucky of the one part & **Jeremiah Meeks Bazil Meeks John Meeks Junior & Joshua Meeks** of Henry County & State of Kentucky other part

Witnesseth, that the said John Pope for & in consideration of the Sum of five Shillings to him in hand paid hath granted bargained & sold & by these presents doth grant bargain & sell unto the afor.d Jerimiah Bazil John & Joshua a certain track or parcel of land situate in the said County of Henry part of a track of 3704 Acres patented in the name of James F. Moore & this day conveyed by said Moore to said Pope containing by estimation **four Hundred acres** being the land purchased by the said Meeks of Robert Tyler and bounded as follows - to wit, Beginning at an Ironwood Buckeye & elm corner to McKinley and runing, Thence South Two hundred and Sixty six poles to two blue ashes and a black ash, Thence West Two hundred and forty Poles to two beeches, Thence North Two hundred & Sixty Six poles to a Mulberry, Hackberry & Sugartree, Thence East Two hundred & forty poles to the Beginning, Tohave and to hold, the said Track of land be the same more or less with its appurtenances to the said Jerimiah Meeks, Bazil Meeks, John Meeks Junior and Joshua Meeks Their Heirs & Assigns to their only proper use benefit & behoof forever, and the said Pope will warrant & defend the said track of Land against himself his heirs & all those claiming under him but not against the claim of any other person whatever and it is further to be understood & it is expressly agreed between the parties, that the said Pope is not to refund the consideration money or to be responsible in any event in any manner whatever in case the said land should be lost or taken a way by other claims, the said Pope, having sold the said land to the said Jerimiah Meeks Bazil Meeks John Meeks Junior & Joshua Meeks, at a reduced price on account of the Interferences & the uncertainty of the said Popes title, It being the true intent and meaning of this Indenture that the said John Pope should nearly relinquish his titles & Interest to the said Meeks's In Testimony Whereof the said Pope has herunto set his hand & affixed his seal the day & year above written

This Indenture made this fifteenth day of November Eighteen Hundred between James F Moore of Jefferson County & State of Kentucky of the one part & John Pope of Shelby County of the other part Witnesseth that the said James F. Moore for & in consideration of the sum of five Shillings to him in hand paid the receipt whereof he doth hereby acknowledge hat bargained & sold 7 by these presents doth bargain & sell to the said John Pope a certain track or parcel of land situate in Henry County on Drennon's lick creek & its waters entered in the name of said Moore & William Shannon Dec.' & patented in the name of said Moore containing by survey 3704 acres including **Sixty acres** this day conveyed by said Moore to **Jacob Meeks** which is excepted out of this Indenture, which track of 3704 is bounded as follows, to wit, Beginning at a Sugartree walnut & hoop ash corner to Jacob Newland running with his line South & West 358 poles to his south west corner a honey locust ash & hickory, South 82 East 179 poles to an ash elm & honey locust in a line of James Hannahs preemption South 8 West 128 poles to Walnut honey locust & buckeye corner to said Hannah, Thence with a nother line of said preemption South 82 East 283 poles to three hickories corner to said Hannah & Charles Seamans 1,000 Survey and with a line thereof S 5 East 286 poles to 2 white oaks corner to said Seaman S 85 West 930 poles to a large beech North 1 E 970 poles to two beeches South 82 East 504 poles to the Beginning. To have & to hold the said track of land be the same more or less with its

appurtenances, to the said John Pope his heirs & assigns to their only proper use benefit & behoof forever and the said Moore will Warrant & defend the said track of land against himself his heirs & all those claiming under him but not against the claim of any other person whatever and it is further to be understood & it is expressly agreed between the parties that the said Moore is not to refund the consideration money or to be responsible in any event in any manner whatever in case said land should be lost or taken a way by other claims. The said Moore having sold the said land to said Pope at a reduced price on account of the interferences and the uncertainty of the said Moores title It being the true intent & meaning of this Indenture that the said Moore should nearly transfer his title & interest to the said Pope. Moore of Jefferson County & State of Kentucky of the one part & Charles Lynch of Shelby County & State aforesaid of the other part Witnesseth that the said Moore for and in consideration of the sum of five Shillings to him in hand paid the receipt whereof he doth hereby acknowledge hat bargained & sold to the said Lynch the one Moiety of a certain tract of land on Drennons lick Creek & its waters in Henry County entered in the name of said Moore & William Shannon & Patented in the name of said Moore & Samuel Shannon devisee of said William containing by survey 3330 acres including **Ninety acres** this day conveyed by said Moore to **Jacob Meeks** which is excepted out of this conveyance which said tract of 3330 acres is Bounded as follows, to wit, Beginning at a Sugartree ash and Mulberry beginning corner of James Hannahs preemption, thence North 82 West

283 poles with his line to his upper corner a Sugartree on a large branch

S.&W 80 poles with a nother of his lines to two white oaks & thorn bush corner to Jacob

Newlands 1100 Acre Survey North 82 West 639 poles with said Newlands line & passing his corner to three beeches near a branch of Drennons lick creek, North 8 East 600 poles to an Ash & beech on the side of a ridge

Joshua Meek to John Samuels 5 shillings for for 100 acres on waters of Drennon Creek, uncertainty of Title, supposed interference, sold at reduced price.

Deed Book #3, page 51, 19 March 1807

Jacob Meek and Elinor his wife, to Anthony Bartlett \$835.00 for 82 ½ acres more or less on west fork of Drennon Creek, being part of two surveys in the name of Moore and Shannon.

Deed Book #3, page 792, 10 May 1810

John Meek to Barksdale Meek 5 shillings for 140 acres on waters of Drennon Creek, part of 2000 acres survey to Woodcock to Meek.
(Ed. Note: Barksdale Meek=Bazil Meek born 1774)

Deed Book #4, page 312, 21 April 1813

Jeremiah L. Meek of Indiana Territory to James Bartlett of Henry County, Kentucky \$80 lot 63, New Castle.

Deed Book #4, page 320, 10 Nov 1812

Evan Thomas and Mary, his wife of Jefferson Cy, Indiana Territory, to **Bazel Meek** of Henry County, Kentucky \$160.00 for 62 acres on waters of Drennon part of \$2000 acres survey.

Deed Book #5, page 119, 23 August 1815

Bazil Meek and Elizabeth Meek, his wife, to John Foree, both of Henry County, Kentucky \$575.00, for a tract of land on waters of Drennon Lick Creek, 140 acres being part of 2,000 acres survey conveyed to Lynch to Woodcock, to John Meek to Bazil Meek.

James Bartlett & Elizabeth his wife to **Bazil Meek**, both of Henry County, Kentucky, \$1.00 for 62 acres lying in Henry County, Kentucky.

do sell and convey to the said Johnathan Meek the property on ridge between Drennon Creek and Emily Run, joins John Meek.

Edmond Searcy to Joshua Meek, \$250.00 for 50 acres on waters of Drennon Lick Creek, Beetums corner on David Galbreath line. Teste Jesse Meek & John Meek

Deed Book #13, page 21, 5 May 1828

Jesse Meek takes mortgage for \$65.00 on livestock, 60 acres land, tools, household goods from Hugh Beetum being the same land said Beetum purchased from David Galbreath.

Deed Book #13, page 50, 4 June 1828

Hugh Beetum to Jesse Meeks, both of Henry County, Kentucky \$300.00 for 60 Acres on Flag Run a branch of Drennon Creek, being the same land deeded to Beetum by Edmund Thomas a commissioner for the heirs of David Galbreath deceased.

Deed Book #13, page 585, 21 May 1830

Bazil Meek, Sen., to Jesse Meek for \$300.00 a tract of land on waters of Drennon Creek, containing 79 acres bounded by Jeremiah Meek & Jesse Meek Spring Branch.

Deed Book #14, page 84, 24 Sept, 1830

Joshua Meek & Jane Meek, his wife, formerly Jane Perkins of Wayne County, Indiana sells to Jonathan Stanley of Union County, Indiana for \$200.00 all their dower right interest, a track of land in Henry County, Kentucky on waters of Drennon Creek being part of the survey of Shannon & Moore 101 acres.

Deed Book #14, Page 236, 21 June 1831

Joshua Meek & Sally his wife to Thos Brown, \$200.00 for a tract of land on waters of Drennon Creek, 50 acres, joins David Galbreath, now, Hugh Beatum.

Deed Book #16, page 33, 14 April 1834

Jesse Meek to Hugh Beatum \$300.00 for 60 acres on waters of Flag Run a branch of Drennon Creek.

Deed Book #16, page 197, 1 Dec 1834

John Mosby to Jonathan Meek for \$50.00 bounded by John Meek, ect. Being part of a survey and grant of 2117 acres patented to Robert Pleasant, 23 acres.

Deed Book #18, page 325, 23 March 1839

Thos Smith and wife Harriett to Jonathan Meek for \$200.00 land on waters of Flag Run Creek, 78 acres, beginning at Jesse Meeks Spring Branch to Beetums ect.

Deed Book #18, page 473, 4 March 1839

Hugh Beetum & Nancy, his wife to **Lee Meek** for \$500.00 60 acres on Drennon Creek, bounded by Jesse Meek

Deed Book #19, page 170, 11 November 1841

Joshua Meek and Jane Meek of Wayne County, Indiana, to Wm. Galbreath of Henry Co., Kentucky for \$200.00 their undivided interest in a certain track of land in Henry County, Kentucky on the waters of Drennon Lick Creek, known as the farm of William Galbreath, deceased.

John Meek to Thomas Smith of New Castle, 400 acres on Drennon Creek as mortgage for \$1996.25 for same land.

Joshua Meek & Jane Meek, his wife, to William Galbreath

Deed Book #20, page 333, 25 Nov 1839

John Hite, trustee to **Bazil Meek**, 196 acres, bounded by Jesse Snell

Deed Book #20, page 334, 21 Nov 1841

Thomas Smith & wife, Harriet to **John Meek** for \$2700.00 acres on waters of Drennon Creek and Emily Run, the same land sold to said Meek 8 Apr 1841

Deed Book #20, page 432, 1844

For \$75.00 **Jacob Meek** made a note to Johnson and Berry.

Deed Book 23, Page 160-161, 24, October 1849.

Barlow Meek & Leanora, his wife, to Wm. Sutton \$350.00 for 50 acres, on the waters of Drennon Creek, beginning at Jonathan Meek, corner in Jesse Meek line, being the same land conveyed to Thomas Brown by Joshua Meek in 1831 and the same brown conveyed to said Barlow Meek & Lennah.

Deed Book 23, Page 306, 26 April 1850

Jonathan Meek & Catharine his wife, deed to Wm. Sutton for \$625.00 - 133 acres, beginning at Jess Meeks Spring Branch, to Jesse Meek line.

Deed Book 23, Page 308, 6 March 1837

Norbon B. Cook to Jonathan Meek \$250.00 for 55 acres on Drennon Creek bounded by Barlow Meek, corner of **Bazil Meek** Spring Branch.

Deed Book #24, page 564, 1 October 1852

Bazil Meek & Nancy, his wife to Greenberry Tingle \$1681.40 for 240 acres on waters of Drennon Creek, joined Jesse Snell.

*Deed Book #24, page 584, 1 August 1852

John Meek & James Meek to Jesse Snell, Jesse Snell takes a mortgage on growing crops of tobacco, farming tools, household and kitchen furniture etc., to secure said Snell in the payment of five hundred and fifty dollars that the said Snell paid to John Meek for a tract of land in Owen County, Kentucky on the waters of the Kentucky River about 1 mile from Willis Ferry to which land the said John Meek has no deed. Recorded September 28, 1852.

(Ed. Note: This may be John Meek born 1801 who married Elizabeth Claxon. He was not related to John, Jacob and Basil Meek of Henry Co., KY.)
